Notes for 2019 Year End

- 1. The parish completed the active phase of the Family of Faith campaign in the fall of 2015. Pledges totalling \$990,000 were activated. Assuming all these pledges are fulfilled in their entirety, the parish will receive approximately \$484,000 over a 5 year period. To December 31, 2019 \$372,729 has been received by the parish.
- 2. In addition to the ShareLife collection of \$66,319, the amount of \$29,898 was donated directly to ShareLife and is credited to our parish. Our 2019 ShareLife total is therefore \$96,217 (2018 \$88,243).
